	AN ORDINANCE TO ENTER INTO THE TEMPORARY EMPLOYMENT OF TEMPORARY EMPLOYEES FOR EMS SERVICES FOR BELPRE RESIDENTS		
	Whereas, the City of Belpre has voided its contract with Belpre Volunteer Fire Department, Inc. for the provision of Emergency Services for Belpre residents, and		
	Whereas, the City of Belpre is also trying to provide temporary EMS services provided by temporary employees of the City of Belpre,		
	NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:		
	SECTION I		
	The Belpre City Council hereby finds that the City of Belpre shall need to be able to provide EMS service to the City of Belpre on a temporary basis with other public agencies and temporarily employed EMS licensed employees using Belpre Volunteer Fire Department equipment.		
	SECTION II		
	The Belpre Mayor and Safety Service Director are hereby authorized to interview and hire temporary EMS employees to provide EMS services to Belpre City residents.		
	SECTION III		
*	The Belpre City Council hereby authorizes the expenditure of up to \$27,500 (Twenty-Seven Thousand Five Hundred Dollars) from the EMS contract fund for EMS expenditures for temporary employees, drugs and equipment for EMS services on a temporary basis of up to 120 (one hundred twenty) days. Said contract expense would have been allocated for 3 months EMS services and \$10,000 (Ten Thousand dollars) for drugs and equipment. SECTION IV This Ordinance is hereby declared to be an emergency measure deemed necessary for the immediate preservation of the public health, safety and welfare of the City, and for the further reason for the provision of emergency medical service wasn't being provided to Belpre citizens at all times.
