RESOLUTION NO. #2 (2022-23)

**A RESOLUTION PROVIDING FOR THE RENEWAL OF 1.75 MILL
ADDITIONAL TAX LEVY FOR PROVISION OF FIRE AND
EMERGENCY MEDICAL SERVICES FOR THE CITY OF BELPRE**

WHEREAS, the voters for the City of Belpre, Ohio passed a ONE AND THREE-QUARTERS (1.75) MILL tax levy on November 17, 2017 to provide fire and emergency medical services for the City of Belpre; and

WHEREAS, the FIVE (5) YEAR term for said the levy shall expire on December 31, 2022; and

WHEREAS, the Administrators and Council for the City of Belpre have determined that said tax levy shall be renewed for an additional FIVE (5) YEARS;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

The renewal of the FIVE (5) YEAR Additional Tax Levy for ONE AND THREE-QUARTERS (1.75) MILL shall be levied against all real estate located in the City of Belpre that is not exempt from real estate taxes. The purpose of this renewal of the FIVE (5) YEAR Additional Tax Levy shall be to provide additional funding for fire and emergency medical services as provided in Ohio Reserved Code §5705.19 (J).

SECTION II

This renewal of the FIVE (5) YEAR Additional Tax Levy on real estate shall provide for an additional levy of ONE AND THREE-QUARTERS (1.75) MILLS outside of the TEN (10) MILL line taxation.

SECTION III

Said levy shall remain in effect for a FIVE (5) YEAR period. Additional Tax Levy shall be effective for the years of 2022, 2023, 2024, 2025 and 2026.

SECTION IV

Said Renewal of the FIVE (5) YEAR Additional Tax Levy shall be presented for approval by electors for the City of Belpre as provided by law at the primary election to be held on May 3, 2022.

SECTION V

The Clerk of the Belpre City Council shall certify a copy of this RESOLUTION to the Board of Elections for Washington County, Ohio, not later than February 1, 2022, and shall request the Board to provide for Notice of said election requested by law.
