**A RESOLUTION AUTHORIZING THE APPLICATION TO THE INFLATION
REDUCTION ACT (IRA) URBAN FORESTRY GRANT THROUGH THE
OHIO DEPARTMENT OF NATURAL RESOURCES** *CAS AWARD*

WHEREAS, the Ohio Department of Natural Resources, Division of Forestry IRA urban forestry grant program addresses the critical need to restore and improve community forests, and to build community resiliency, and improve the quality of life for citizens and visitors of ~~Steepport~~ *Belpre (Mead)* through the management, protection, and planting of trees.

WHEREAS, the City of Belpre desires financial assistance through this program to enhance the City of Belpre tree care program, and to reestablish trees and tree canopy in public places throughout the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

Council hereby authorizes the application to the Ohio Department of Natural Resources, Division of Forestry, for financial assistance in an amount not to exceed \$50,000, for the provision of all information and documentation required to become eligible for possible funding, assistance, and execution of any agreements necessary to receive any awarded funds.

SECTION II

Council hereby agrees to obligate the funds necessary to complete the proposed project and become eligible for full reimbursement under the terms of the grant program.

SECTION III

Council determines that all formal actions of this Council, concerning and related to the passage of this resolution, were taken in an open meeting of this council, and that all deliberations of this council, and any committee that resulted in those formal actions were in meetings that were open to the public in compliance with the law.

SECTION IV

This resolution is hereby declared to be an emergency measure immediately necessary for the timeline of the grant schedule and the preservation of the public peace, health, safety and welfare, and for the further reason that is necessary to authorize the filing of the said, application, on or before December 29, 2023, to provide that this resolution shall be in full force, and take effect immediately upon its passage approval by the Mayor and Fiscal officer.
