Mrs. Dennis made a motion to accept the minutes of May 09, 2022 as presented and by-pass the reading. A vote was taken with members of council present voting aye.

# **Reports of City Officials:**

Mayor Lorentz reported the Civitan is trying to acquire a grant to refurbish their portion of the parking lot. At this time, I am getting numerous estimates so to apply for Foundations funds.

I reported a few weeks ago that I spoke to the Mobile Home Authority in Columbus about some of our issues here. On Tuesday I met with the Southeast Ohio Legal Services and residents of one of our mobile home parks. Hopefully these folks now have a voice and improvements will be made.

Wednesday May 18<sup>th</sup> was the official or formal start with the Memorial Bridge rehab. A delegation of chamber members, elected officials and others gathered to hear their plans and celebrate the much-needed improvements and the cooperation between communities.

May 19<sup>th</sup> the Safety-Service Director and I attended the Chamber Luncheon. The sponsor was North Bend Wealth Management.

Election of officers was held for the Interstate Planning Commission. Randy Rapp is vice chair, and I will again be the Chairman.

One of our dispatchers verbally told Chief Williams of his intent to resign and enter a training school in a different vocation.

The light at Maple and Washington Blvd. should be complete this week. My intent is to have it on a cycle much like the light at the shopping center, active from 7-am until 7-pm and flashing 7-pm until 7-am.

Saturday is National Poppy Day in Belpre. Make sure you stop and get your Poppy from the American Legion Auxiliary Saturday morning.

If anyone knows the whereabouts or knowledge of who soaped our fountain, please let the Chief or me know. The pump, landscaping and flowers get pretty expensive especially when vandalism causes the replacement.

The pool is ready to go with no leaks this year. Our pool slide is repaired and ready for opening day May  $30^{th}$ .

Safety-Service Director Mrs. Hoblitzell was absent. No report was given in her absence.

City Auditor Mrs. Nolan announced that the items requested from Julian and Grube are 98% completed for the June 6 City Audit.

We continue collecting data from Software Solutions and will deliver as soon as possible.

Legislation is written for the first 2022 Supplemental Appropriations and will need Councils approval.

The April Utility Adjustment report copies are on the back table and needs Councils approval.

Mrs. Dennis made a motion to accept the Utility Adjustment Report as presented. A vote was taken with all members of council present voting aye.

City Law Director Mr. Webster had no report.

All officers received a coupon from Jersey Mike's and also, I brought in donuts for the police officers. I hope you all thanked a police officer, a dispatcher and the clerk last week.

Mr. Ruth, Streets, Sidewalks and Storm Sewer reported that he did a follow-up with Dave Shaffer regarding some of the items that came up at the last meeting. Some of the items were the pot holes on Murray Street. He was informed that they are trying to get to that this week or the first of next week. Also mentioned was the pool that they have been working on to get it ready to open and the traffic light that Dr. Brian Eaton addressed at the last meeting. Mr. Ruth was informed that they are bringing in a 3<sup>rd</sup> Party person that will reset that light from 7am-7pm. I also asked about the grass problems and the Clayton and Poplar Storm Sewers which are all being addressed.

Mr. Millhone, Utilities Committee stated that he has a continuation petition with 40 signatures on it regarding the intersection of Washington Boulevard and Maple Street traffic light. You have eluded that the light is going back on however I will submit the petition to the clerk. Mr. Millhone asked the mayor if the traffic signal was going to be turned back on. According to the mayor the light will be on from 7am-7pm just like the one in front of the shopping center

Mr. McClead, Parks and Recreation Committee reported that his committee met at 7pm prior to this evening meeting to discuss the RC Track at the park. Also, I was contacted regarding the Volleyball Court needing tilled and sand. I will get with Connie about this when she returns from vacation.

Mr. Wallace, Planning and Zoning Committee announced that a public hearing has been scheduled for June 8th at 9:00 a.m. in the City Council chambers located at 715 Park Drive, Belpre Ohio. This hearing is to allow property owners within 100 feet of the proposed requested area to express any concerns.

The property owner(s) of 712 Franklin Avenue is requesting a zoning variance on the from setback regulations as per Ordinance 1149.02 (e) A-3. The proper front yard setback is twenty feet. The proposal is for a 12x21 foot metal carport, no sides, to be placed over a concrete driveway. The structure will sit within the 20-foot front setback area. The front of the structure is approximately 6  $\frac{1}{2}$  feet from the curb. The corners of the proposed structure are marked with yellow flags.

Mr. Wallace, Economic Development Committee had no report.

Mr. Null, Rules Committee was absent. No report was given in his absence.
