#### EXHIBIT A

#### MEMORANDUM OF UNDERSTANDING

### **BETWEEN THE CITY OF BELPRE LOCAL 3507**

This Memorandum of Understanding is entered into this day between the City of Belpre, ("Employer") and the American Federation of State, County, and Municipal Employees ("Union"), Local 3507, Ohio Council 8, AFL-CIO.

The Parties have met and have agreed to the following changes to Article 26. The full Article is listed below:

### ARTICLE 26 CLOTHING

Section 26.1. Clothing - The Employer will furnish each employee in the Water/Sewer Department, Wastewater Treatment Plant, and Street Departments with one (I) set of rain gear, work gloves, and muck boots for employees' use at job sites. Employer shall also provide hard hats, ear plugs, safety glasses, knee pads, harnesses and any other specialized equipment and protective gear needed for specific duties and are property of the city after use. Work gear listed above shall be replaced by the Employer when it is sufficiently worn.

The parties understand that rain gear, work gloves and rubber boots are the property of the City and will be returned to the City when an employee resigns, retires, or is terminated.

Section 26.2 City shall furnish work clothing and protective equipment as deemed necessary by the responsible Department Head to protect the employees in their job assignments, as well as identifying all employees as City staff members. Failure to wear the provided clothing and safety gear maybe subject to disciplinary action. Supervisors and Department Heads shall determine if clothing is no longer serviceable and may not be worn on duty.

City agrees, employees will use the purchase order process. To receive any clothing or use any uniform allowance, the employee must be on active pay status.

The City shall provide the following items in the following manner;

The City shall provide new hires with an initial issue of five (5) sets of clothing. Should the new hire not pass probation and does not return the initially issued clothing, the city may take the cost of the initial issue from their last payroll check.

Clothing shall offered once annually in January all other clothing and equipment shall be replaced on an as needed basis.

All purchase will follow the City's purchasing process. "Per year" means calendar year.

Employees shall receive a separate check for six hundred dollars (\$600.00) in the first full pay in January (beginning January 2024 and January 2025) to be used for work clothing and boots.
