CITY OF BELPRE RESOLUTION NO. 7 (2024-2025)

A RESOLUTION AUTHORIZING THE BELPRE MAYOR AND AUDITOR TO ENTER INTO CONTRACT WITH INVOICE CLOUD INC. TO PROVIDE BILLING SERVICE FOR MONTHLY WATER/SEWER BILLS FOR THE CITY OF BELPRE

WHEREAS, the City of Belpre currently has a contract with Software Solutions, Inc. Their contract provides for new computer software for all City departments, and

WHEREAS, the Mayor and Auditor has discussed that the software currently used for Water/Sewer monthly billing PSN is not compatible with the new software system to be provided by Software Solutions Inc., and

WHEREAS, Invoice Cloud Inc., has available a software program for billing to be paid online.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

Upon recommendation of the Belpre City Mayor and Auditor, the Belpre City Council has reviewed the biller agreement and statement of work provided by Invoice Cloud, Inc to provide online payments for monthly water/sewer billings.

A copy of said documents are attached hereto as Exhibit A

SECTION II

The Belpre City Council hereby finds that it is in the best interest of the City of Belpre and all users of Belpre City water and /or sewer services, that the City of Belpre should enter into the contract with Invoice Cloud, Inc.

Therefore, the Belpre Mayor and Belpre Auditor are hereby authorized to sign all documents to create the contract with Invoice Cloud Inc. for the provision of the computer software

SECTION III

This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, welfare and safety and for the further reason that the legislation needs to implement as soon as possible to allow for the installation of the software, testing of the software and the public education process to allow for the implementation of the new software by October 2024
