AN ORDINANCE TO AUTHORIZE THE MAYOR OF BELPRE TO EXECUTE A DEED AND OTHER DOCUMENTS TO ENABLE THE TRANSFER OF REAL ESTATE FROM THE CITY OF BELPRE AND TO ACCEPT THE TRANSFER OF REAL ESTATE TO THE CITY OF BELPRE

WHEREAS, Boxers House Holding, LLC completed a survey of its property currently used for the operation of Boxers Bed & Biscuits business in the City of Belpre; and

WHEREAS, the survey disclosed that the parking lot for the business encroached upon property owned by the City of Belpre used as a drainage ditch; and

WHEREAS, the survey also disclosed that the City of Belpre constructed a fence on property owned by Boxers House Holding, LLC; and

WHEREAS, the City of Belpre has agreed to a property swap with Boxers House Holding, LLC.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

The Mayor has recommended that the City of Belpre should execute the documents required to exchange properties with Boxers House Holding, LLC. A copy of said documents are attached hereto as Exhibit A, pp. 6.

SECTION II

The City Council hereby finds that the parking lot for the business operated by Boxers House Holding, LLC, and previously the Middleton Doll Company, has been in its current location for a number of years. Further, the City Council finds that the grass strip areas and part of the parking lot area has been used by the City of Belpre and its employees for the mowing and maintenance of the ditch located to the east of the parking lot. The Council finds the easement reserved by the City of Belpre in the proposed deed will allow for the continuance of the maintenance and mowing of the ditch area.

SECTION III

The Council for the City of Belpre finds that it is also in the best interest of the City of Belpre to acquire the triangular strip from Boxers House Holding, LLC to allow the City to retain the location of its fence to the north of this property. Further, the City Council finds that the transfer of the 10-foot strip of real estate from Boxers House Holding, LLC to the City will allow for the further installment of a 10 foot sidewalk area.
