CITY OF BELPRE RESOLUTION NO. 16 (2024-2025)

A RESOLUTION AUTHORIZING THE MAYOR OF BELPRE TO SELL A 2022 KW KENWORTH MOTOR TRUCK TO THE CITY OF ATHENS, OHIO

WHEREAS, the City Administration has determined that the City of Belpre needs to purchase a smaller truck for snow removal and other City purposes; and

WHEREAS, the Safety-Service Director has contacted county, city, township and village departments in Southeast Ohio and West Virginia to determine if any are interested in the purchase of this vehicle for the price of \$120,000; and

WHEREAS, The City of Athens, Ohio has submitted the highest bid of \$110,000 for the purpose of the 2022 KW Kenworth Motor truck.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

The Belpre City Council hereby finds that it is in the best interests of the City of Belpre to purchase a smaller truck for snow removal and other City purposes.

SECTION II

The Belpre City Council finds that the administration has sought bids from other government agencies and that the highest and best bid for 2022 KW Kenworth Motor truck and attachments is \$110,000 by The City of Athens, Ohio, and therefore, authorizes the Mayor to sell the truck to the City of Athens at the bid price of \$110,000. A copy of the current Certificate of Title is attached hereto as Exhibit A.

SECTION III

This resolution is hereby declared to be an emergency measure immediately necessary for the timeline of the grant schedule and the preservation of the public peace, health, safety and welfare, and for the further reason that snow removal services may be required as early as November, 2024, and that the funds generated from the sale of the truck shall need to be applied to the purchase price of a new replacement vehicle.
