AN ORDINANCE PARTIALLY VACATING AN ALEY LOCATED TO THE EAST OF THE INTERSECTION OF WASHINGTON BOULEVARD AND WALNUT STREET

WHEREAS, Go-Mart, Inc, filed a petition with the Belpre Planning and Zoning Board of Appeals to vacate 165 feet of an alley located North of Washington Boulevard and 160 feet east of Walnut Street; and

WHEREAS, on October 25, 2024, Bob Rouch, Chairman of the Belpre Planning and Zoning Board of Appeals reported to the Mayor that the Board had approved the petitioner's request by a 3-0 vote (copy of the notice is attached hereto as Exhibit A); and

WHEREAS, the Belpre City Council Planning and Zoning Committee Chairman, Mr. Godfry, has requested that the petition be enacted by the Belpre City Council.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

Petitioner, Go-Mart, Inc. has filed a petition for the vacation of 165 feet of the alley located 160 feet east of Walnut Street at the southeast corner of Lot No. 153 in the City of Belpre. A Public Hearing was held on the petition in City Council Chambers on November 25, 2024, at _______p.m.

SECTION II

The Belpre Planning and Zoning Board of Appeals approved the petition on October 25, 2024.

SECTION III

The Council for the City of Belpre finds that legal notices were sent to the appropriate landowners with property adjoining the area to be vacated. The Planning and Zoning Committee has recommended that the petition be approved.

SECTION IV

The Belpre City Council has considered the recommendation of the Belpre Board of Planning and Zoning Board of Appeals, and the Council Planning and Zoning Committee and further finds that there is good cause for such vacation of said alley, and that such vacation of the alley will not be detrimental to the general interests of the public and ought to be made. Therefore, the alley located 160 feet east of Walnut Street at the southeast corner of Lot No. 153 in the City of Belpre and being 13 feet wide shall be vacated in a northerly direction for 165 feet. As a condition of said vacation, the City of Belpre shall retain the easements for all City water and sewer lines located within and under said vacated area (2145 square feet).
