This Stormwater Inspection and Maintenance Agreement, made this day of, 20, by between (hereafter the "OWNER") and the City of Belpre (hereafter the "CITY"), prov as follows:	
WHEREAS:	
• The <b>OWNER</b> is responsible for certain real estate shown as Lot Number on recorded Plat that is to be developed as and referred to as the "PROPERTY."	_
<ul> <li>The OWNER is providing a post-construction stormwater management system consisting of stormwater control measures as shown and described within the CITY approved Stormwater Pollution Preven Plan(s) and Post-Construction Stormwater Operations and Maintenance Plan(s) on file with the CITY and pertaining to the PROPERTY.</li> </ul>	tion
• To comply with the <b>City of Belpre Codified Ordinances</b> , the <b>OWNER</b> has agreed to maintain the stormwater control measures in accordance with the terms and conditions set forth herein.	

### NOW, THEREFORE, the parties agree as follows:

#### 1. Construction and Maintenance of Facilities

The on-site stormwater management facilities shall be constructed by the **OWNER**, its successors, and assigns, in accordance with the plans and specifications identified in the **Plan**. This agreement does not constitute approval or acceptance of the completed stormwater management facilities by the CITY, which approval, if given, shall be by a separate written document executed by the CITY.

The **OWNER** agrees to maintain in perpetuity the stormwater management system in accordance with the approved **Stormwater Pollution Prevention Plan(s)** to ensure that the measures remain in proper working condition and in accordance with the standards by which they were designed. The **OWNER** shall perform preventative maintenance activities at intervals described in the **Post-Construction Stormwater Operations** and **Maintenance Plan** on file with the CITY.

## 2. Inspection and Reporting

The **OWNER** shall submit to the CITY an **annual inspection report** and copies of the maintenance logs for the past twelve (12) calendar months by **May 31st** of each year. The report shall include the information as outlined in the **Post-Construction Stormwater Operations and Maintenance Plan**, including documentation of inspections, maintenance, remedial actions taken, the state of the control measures, and any changes to the responsibility of the system.

Additionally, the **OWNER** shall submit to the CITY a **professional inspection report**, completed by a professional engineer familiar with stormwater controls and design, once every **five (5) years**.

#### 3. City Inspection Rights

The **OWNER** hereby grants the CITY, its agents, and employees the right to enter the PROPERTY at reasonable times and in a reasonable manner for the purpose of inspecting, operating, installing, constructing, reconstructing, maintaining, or repairing the system. The CITY shall provide the OWNER with copies of inspection findings and a directive to commence repairs if necessary.

#### 4. Failure to Maintain

If the **OWNER** fails to maintain the stormwater management system, the CITY may order the necessary work to be performed within **ten (10) days** of receiving written notice. In the event the work is not completed within the specified time, the **OWNER** agrees to allow the CITY, its agents, or contractors to enter the PROPERTY and perform the required work.

The **CITY** is under no obligation to maintain or repair said facilities, and this Agreement does not impose any such obligation on the CITY. The **OWNER** shall reimburse the CITY upon demand for the costs incurred in the maintenance of the system.

### 5. Failure to Pay for Maintenance

If the **OWNER** fails to pay the CITY for the maintenance costs within ten (10) days after written notice, the OWNER authorizes the CITY to collect the expenses from the OWNER through appropriate legal action. The **OWNER** shall be liable for reasonable expenses, including court costs and attorney's fees.

#### 6. Indemnification

The **OWNER** and its successors and assigns shall indemnify and hold harmless the CITY, its officers, agents, employees, and contractors from any claims or liabilities arising from the construction, presence, or maintenance of the stormwater control facilities. In the event a claim is made against the CITY, the **OWNER** shall defend the claim at their own expense.

## 7. Responsibility of the Landowner

The **OWNER**, its successors, and assigns, including any homeowner's association, shall adequately maintain the stormwater management facilities. Maintenance includes keeping the facilities in good working condition to ensure they perform their intended design functions.

## 8. Covenant Running with the Land

This Agreement shall be recorded in the Washington County Recorder's Office and shall constitute a **covenant running with the land**, binding the **OWNER**, its heirs, administrators, executors, assigns, and any other successors in interest.
