**A RESOLUTION DECLARING 2006 E450 DIESEL FORD
AMBULANCE TO BE EXCESS PROPERTY AND AUTHORIZING
THE SAFETY-SERVICE DIRECTOR TO AUCTION THE 2006 E450
DIESEL FORD AMBULANCE.**

WHEREAS, the City of Belpre is the owner of ambulance; and

WHEREAS, the City of Belpre has purchased a new ambulance; and

WHEREAS, Unit No. 490, 2006 E450 Diesel Ford ambulance is now unneeded to provide ambulance service for the City of Belpre.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNCIL OF
THE CITY OF BELPRE, OHIO, THAT:**

SECTION I

The Belpre City Council hereby finds that the 2006 E450 Diesel Ford ambulance, Unit 490 is no longer needed to be used for ambulance services for the City of Belpre residents and should be declared to excess property value at over \$1000.00.

SECTION II

The Belpre City Council determined that the provisions of Ohio Revised Code 721.15(B), control the sale of the 2006 E450 Diesel Braun ambulance.

SECTION III

The Belpre City Council hereby authorizes the Belpre City Safety Director to obtain an appraisal of the vehicle and then determine the minimum bid for the vehicle and to determine whether the vehicle should be sold at a live auction or an on-line auction. The Safety Director should advertise the vehicle for sale and should determine all the terms and conditions of the sale. (Ohio Revised Code Section 721.15 (D))

SECTION IV

This resolution is hereby declared to be an emergency measure immediately necessary for the timeline of the grant schedule and the preservation of the public peace, health, safety, and welfare, and for the further reason that the new ambulance needs to be insured at the City of Belpre Fire Department Station No. 1, and there are no other indoor secured city facilities where Unit 490 can be retired. This resolution shall be in full force and take effect immediately upon its passage approval by the Mayor and Fiscal officer.


