CITY OF BELPRE
ORDINANCE NO. 21 (2024-2025)

**AN ORDINANCE TO AMEND BELPRE CODE OF ORDINANCES,
SECTION 343.03 (D) INSPECTIONS, FEES, AND FINES.**

WHEREAS, the Clerk for the City of the Belpre Mayor's Court, who is also in charge of record keeping and the issuance of annual stickers for golf carts, has requested that the city implement a different system of payments for permits and inspections.

WHEREAS, committee meetings have been held to consider the proposed changes; and

WHEREAS, the committee has determined that changes should be made to the registration process.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

That the requested changes from the Clerk of the Belpre Mayor's Court should be enacted to simplify the annual registration process for golf carts.

SECTION II

The Belpre Code of Ordinance Section 343.03, INSPECTIONS, FEES, AND FINES, Section (d) shall be amended as follows:

(d) A valid inspection sticker must be displayed on the golf cart. All golf carts must be inspected annually. The fee to be paid for the annual inspection of the golf cart shall be paid directly to the inspector. Once the inspection has been successfully completed, the applicant shall pay a fee of twenty-five (\$25.00) dollars to obtain the annual sticker that shall be payable by check or money order payable to the City of Belpre, to obtain the sticker. The annual sticker shall be valid from April 1 of the year when obtained through March 31st of the next calendar year.

The annual inspection fee may be modified at any time by the Belpre Chief of Police and the Belpre Safety Director.

SECTION III

This Ordinance shall take effect at the earliest time allowed by law.
