ORDINANCE NO. 23 (2024-2025)

**AN ORDINANCE TO AMEND BELPRE CODE OF ORDINANCES
SECTION 1313.08 (C) SERVICES.**

WHEREAS, the Safety Service Director and Code Enforcement Official have requested that Belpre Code Ordinance Section 1313.08 (c), Service should be amended; and

WHEREAS, the requested amendment was referred to the Belpre City Council Planning and Zoning Committee; and

WHEREAS, the Planning and Zoning Committee considered the amendment at committee meeting held on February 10, 2025, and recommended that the amendment be enacted.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

Upon the recommendation of the Planning and Zoning Committee, the Belpre City Council has reviewed the recommended proposal to amend Belpre Code Ordinance Section 1313.08 (c), Service.

SECTION II

The City of Belpre Council hereby finds that proposal amended is reasonable and should be adopted.

Therefore, the last sentence of Belpre Code Ordinance of Section 1313.08(c) Services which currently states:

“at least one publication of such notice in a local newspaper or general circulation at least once a week for three (3) consecutive weeks”

Shall be Amended to the following language:

“In lieu of publication, such notice may be posted at least twenty-one days prior to the hearing or prior to the expiration of any deadline contained in the notice, in at least two locations, one of which shall be the property upon which the violation is alleged to exist, and the other shall be at the City of Belpre website www.cityofbelpre.com under Legal Notices, for such

notices. Proof of posting shall be by affidavit of the person posting the notice, which affidavit shall include a copy of the notice posted and the date places of its posting.”

SECTION III

This Amended Ordinance shall be in effect at the earliest time allowed by law.
