Council President Mr. Martin called the May 26, 2025 Belpre City Council meeting to order at 7:30 pm. Absent from the meeting was Mr. Ambrozy, Ms. Riffle, Safety-Service Director Mr. Kirby, City Auditor Mrs. Nolan and Treasurer Mrs. Cassady.

Council President Mr. Martin asked everyone to please rise for the Prayer and remain standing for the Pledge of Allegiance. Council President Mr. Martin gave the invocation and led us in the Pledge of Allegiance.

Council President Mr. Martin asked all present if you have cellphones or any electronic devices to please turn them off or to vibrate so it won't interfere with the recording.

If you plan to address council this evening, please rise, come to the podium, state your name clearly so the clerk can get your information, and address council.

Council President Mr. Martin asked for a motion for the May 12, 2025 meeting minutes. Mrs. Dennis made a motion to approve the minutes of May 12, 2025 as presented and by-pass the reading. A vote was taken with all members of council present voting aye.

### Reports of City Officials:

Mayor Abdella presented her report to council. It is as follows:

#### Communications:

First, Today is Memorial Day a day to remember all that have served to protect our Freedom and our nation. I would like to thank you and Ms. Riffle for your service to our nation. Please remember those that served that made the ultimate sacrifice and those that returned home with scars that are seen and some not visible; we cannot forget the families, spouses and children that sacrificed so their loved ones could serve our nation. I hope each of you took a moment to remember this important day.

Today I had the honor of attending the Belpre Area Veterans Memorial service. What a wonderful tribute to those that served.

 Mr. President- I am requesting a voice vote for council to reappoint Joel Whitaker to the Belpre Marietta Health Board. His term is currently expiring. Also, the Marietta Belpre Health Department received State Accreditation at the end of May. This is a big achievement. Kelly Miller was appointed as the administrator to replace Barb Bradley after her retirement at the end of July.

Desire Kerns owner of the Redwood is our other representative.

- On June 9th at 6pm the engineering firm doing the park planning will be here to reveal the plan and discuss the funding options. Also, SOPEC and their grant team is working with us to move this plan forward.
- Later this week, I will be sending the EOP (Emergency Operations Plan) out to you for your review. It is recommended that Council members take the ICS 700 (National Incident Management System an introduction) and the ICS 100 Courses (Introductions to incident command)

#### **City Projects:**

- Trash Contract This Bid was awarded to Rumpke; we are in the process of making the necessary contract changes. This contract allows for a spring and fall cleanup day – dumpsters
- SCADA Project Schedule This project has been modified to make a few of the operational data upgrades that are currently not available. I did visit each booster and lift station with the department heads to be able to update the capital improvement plan.
- MXU Radio replacement- This work is in full swing at this time. We are hoping to complete it mid-summer. Remember when we went to the water department and it was full of meters. It is now almost empty, which is a good thing.
- Backflow tracking This EPA requirement has been a challenge. However, Angie, Clint
  and Chris has this process operationalized and the response from the homeowner and
  businesses is good, the challenges is from the service side if the backflow needs repaired
  as the supply chain issues have delayed them getting parts to repair commercial ones.

City Law Director Mr. Webster had no report.

City Treasurer Mrs. Cassady was absent.

Mr. Ferguson made a motion to approve the April 2025 Treasurer's Report as presented. Mr. Ferguson informed council that the auditor found the .59 cents under 2214 Recreation Facilities. He was informed that this will clear off the Treasurer's Report in May. A vote was taken with all members of council present voting aye.

Mr. Seebaugh Parks and Recreation Committee had no report.

Mrs. Campbell Planning and Zoning reported that her committee met at 7:00pm this evening for the purpose of discussing A RESOLUTION AUTHORIZING THE CITY OF BELPRE TO ENTER INTO A COMMUNITY HOUSING IMPACT AND PRESERVATION PROGRAM PARTNER AGREEMENT. Mrs. Roberts is handicapped and announced that there was no handicap accessibility at the market. She would like to use the market here in Belpre rather than traveling to Marietta. Mayor Abdella was going to do some checking and talk to Dr. Freed about seeing if there is a plan in place to make the market a more handicap accessible event.

Mayor Abdella announced that the bathrooms at Civitan Park are closed due to a water issue. They will be closed until tomorrow when the guys can get down there and resolve the issue. Once resolved they will be reopened.

City Law Director announced that on ESPN today there was a story about a Hockey Team in the Boston area that were in the State Championship in Massachusetts and attended a Catholic School Memorial Day Service of a veteran who had no family. The hockey team served as pallbearers for the veteran.

Mr. Webster also stated that there was a B24 airplane that was shot down in 1944 into the Pacific Ocean. There is an organization that looks for POW remains. They were able to find the B24 aircraft and the remains of 14 crew members. They were having a special service to honor these crew members. Mr. Webster stated that veterans are not forgotten.

Mayor Abdella received a letter from a young lady whose parents lives in our community and is a Marine. The letter was to Staff Sergeant Bunner who was a non-commission officer for the US Marine Corp. She was recognized for her patriotism and perseverance to our country. Today I would like to recognize her and her parents who is in our community and are so very proud of her.

Mr. Martin stated that he hopes that everyone has had a wonderful Memorial Day Weekend with family and friends. He wished everyone a good rest of the weekend. He stated that our Nation is at Peace and not at war. This is phenomenal.
