CITY OF BELPRE ORDINANCE NO. 24 (2024-25)

AN ORDINANCE AUTHORIZING MAYOR SUSAN ABDELA TO APPLY FOR, ACCEPT, AND ENTER INTO A COOPERATIVE AGREEMENT FOR CONSTRUCTION OF THE SCADA SYSTEM FOR THE WATER AND SEWER DEPARTMENTS BETWEEN THE CITY OF BELPRE AND THE OHIO WATER DEVELOPMENT AUTHORITY AND DECLARING AN EMERGENCY

WHEREAS, the City of Belpre (hereinafter referred to as the "LGA") needs to purchase and install a SCADA (Supervisory Control and Data Acquisition) system that allows operators to remotely monitor and control water and wastewater treatment and distribution processes, collecting real-time data from various field devices and assets like pumps, valves, and sensors; and

WHEREAS, the LGA desires to obtain a loan from Ohio Water Development Authority (hereinafter referred to as the "OWDA") to finance costs of the construction of such facilities on the terms set forth in the Cooperative Agreement (defined below); and

WHEREAS, the OWDA has indicated its willingness to make a loan for that purpose and on those terms.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COUNCIL OF THE CITY OF BELPRE, WASHINGTON COUNTY, OHIO, THAT:

SECTION I

The LGA, hereby approves the construction of the aforesaid SCADA System in cooperation with the OWDA under the provisions, terms and conditions set forth in the "Cooperative Agreement for State Planning Project" as set forth in Exhibit A (the "Cooperative Agreement") and hereby authorizes the Mayor and the Auditor of the LGA to execute the Cooperative Agreement with the OWDA substantially in the form set forth in Exhibit A.

SECTION II

The LGA has found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were passed in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION III

This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said City of Belpre for the reason that the current SCADA System is not operable and thus the immediate construction of the new SCADA System is needed at the earliest possible time necessary in order to protect the health of the inhabitants of the LGA by providing operators to remotely monitor and control water and wastewater treatment and distribution processes, collecting real-time data from various field devices and assets like pumps, valves, and
