CITY OF BELPRE ORDINANCE NO. _______ (2024-25)

AN ORDINANCE TO AMEND ORDINANCE NO. 8 (2024-2025) ESTABLISHING WATER RATES

WHEREAS, the Council for the City of Belpre, Ohio passed Ordinance No. 8 (2024-2025) on September 3, 2024, which provided for the establishment of new water rates to be effective October 1, 2024, in the amounts according to the schedule attached as "Exhibit A" to the Ordinance; and

WHEREAS, "Exhibit A" as attached was the schedule submitted with the proposed Ordinance, but "Exhibit A" had been amended by the City Council on August 2, 2024.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

The Belpre City Council hereby finds that the incorrect "Exhibit A" was attached to Ordinance No. 8 (2024-2025).

SECTION II

The Council for the City of Belpre, Ohio hereby amends Ordinance No. 8 (2024-2025) to adopt the proper "Exhibit A" to Ordinance No. 8 (2024-2025), as follows:

"Effective October 1, 2024, water rates for the City water systems are established as follows:

Residential customers inside Belpre city limits will have a base rate of \$13.14 and an additional \$2.32 for every 1,000 gallons used.

Residential customers outside Belpre city limits will be increased by 100% of the inside rate. \$26.28 base rate plus the \$4.64 per 1000 gallon.

Commercial customers inside Belpre city limits will have a base rate of \$19.71 and an additional \$3.48 every 1,000 gallons used.

Commercial customers outside Belpre city limits will have a base rate of \$19.71 and an additional \$3.48 per 1,000 gallons used.

Each water bill will also include the \$4.00 and \$2.00 water improvement charges per previous ordinance.

Effective October 1, 2025, there will be a 20% increase to water rates."
