Council President Mr. Martin asked everyone to please rise for the Prayer and remain standing for the Pledge of Allegiance. Chief Stump gave the invocation and led us in the Pledge of Allegiance.

Council President Mr. Martin asked all present if you have cellphones or any electronic devices to please turn them off or to vibrate so it won't interfere with the recording.

If you plan to address council this evening, please rise, come to the podium, state your name clearly so the clerk can get your information, and address council.

Council President Mr. Martin asked for a motion for the June 23, 2025 meeting minutes. Mrs. Dennis made a motion to approve the minutes of June 23, 2025 as presented and by-pass the reading. A vote was taken with all members of council present voting aye.

# **Reports of City Officials:**

Mayor Abdella presented her report to council. It is as follows:

# **Communications:**

- The Music by the River concerts is in full swing. They have experienced a couple of rain delays but these events are up and running again. The rain delays have been rescheduled for Wednesday evenings. Please watch for the rescheduled dates.
- The Belpre Alumni Ice Cream Social and Car show was a big hit over the weekend. Everyone loves ice cream.
- Lee street is complete. They will be working on stripping tomorrow. We are working on the road grading inventory so that we can get pricing on the next area we want to focus on.
- On July 4<sup>th</sup> I had the pleasure of attending the flag raising and retirement ceremony at the Masonic lodge that was held in conjunction with the Belpre Area Veterans. What a wonderful and moving event. Hearing Eric Clark tell the story of "Old Glory" was very emotional and inspirational. I don't think there was a dry eye at the event.

- On July 9<sup>th</sup> I had the pleasure of attending the celebration of the Northwest Territory ordinance. The governor was present for the celebration. It was a wonderful event. There is so much history in our area to celebrate.
- The preconstruction meeting for the tank project was held on July 3<sup>rd</sup> and you will begin seeing activity in the area.
  - Water Tank Mary Street tank will be the first thing coming off line. Demolition is set for the end of July.
- July 11<sup>th</sup> was the last day for our code enforcement Brandon as he is returning to Florida.
  - We at least got to teach him to drive in snow.
- July 15<sup>th</sup> there is a presentation here in council chambers at 3pm by Guardian Structures to present the ability to build panelized housing. It is a new technology.
- Golf Carts We have had 17 register their vehicles and get inspections. I hope all
  owners that intend to drive them on the road ways as described in our ordinance
  secures the appropriate permits and licensing. The fine for not licensing is \$150 and is
  listed as a minor misdemeanor.
- SB 195 is working on incentives for volunteer firefighters. One is a property tax reduction and another is a tuition waiver program. We will keep our eyes on these incentives. We are hoping to improve the number of volunteer firefighters in rural areas.

#### **Projects**

SCADA – Bid opening pushed back. The bid as read, \$522,500 was the only bid on the project. The Engineer's estimate for the base bid is \$505,000. Micro-Comm, Inc. submitted a bid of \$522,500 which is above the Engineer's estimate of \$505,000.00. This project is within the 20% margins; however, I would like a voice vote to move forward.

Chief Stump talked before council about the danger officers are facing in 2025. The leading culprit is being under staffed. At the request of the mayor, we are going to begin inter departmental training on our own as far as defensive tactics and firearms training goes. Myself and Sergeant Campbell are instructors and will be putting in a lot of training beginning with our own agencies. We are going to get more mandatory training for our officers. We are in the process of looking for candidates at the academy. Local academies are having a hard time getting 10 candidates. With the number of agencies trying to pull from a pool makes it difficult to get candidates. If you go toward Columbus there third year patrolman are making around \$117,000 per year. We are trying to draw attention that we have a police academy here. We shot a promo video today to share. We are trying to push a big public safety boost to bring awareness for the need of people. I encourage the scouts that are her tonight that have a good foundation in scouting to consider someday the possibility of attending an EMS fire and police academy even if it is volunteer. If anyone knows of individuals who may be interested, please have them contact us.

Jon Neff, Scout Master was present with his troop as some of the boy's present are working on their Communication Merit Badge. Cale Mahoney has been working on some requirements such as giving speeches, attending meetings and their active listening skills. After tonight's meeting they will report back to us what they learned from attending the council meeting this evening. Another thing we are working on is Camp Kootaga. Troop 91 is trying to work on saving the camp. They have a down payment in hand and once the foundation gets a hold of it, we are going to have other uses for the camp. Big movement for Economic Development.

Mr. Locke thanked Jon Neff and the scouts for helping out at the Ice Cream Social. They helped a lot.

Mr. Ferguson made a motion to move forward on the SCADA bid. A vote was taken with all members of council present voting aye.

Mayor Abella explained the SCADA Project to the scouts.

Safety-Service Director Mr. Kirby provided council with the updates within the city:

Code Enforcement officer Brandon Miller resigned from his position, and we will be interviewing this coming week for his replacement.

We have been following up on citizen complaints and attempting to resolve what issues is happening.

City Auditor Mrs. Nolan – Thank you Mr. President and Council, the 2025 trash contract was reviewed and evaluated for cost after Rumpke was awarded. No Trash Contract increase will be needed this year. The contract will be evaluated annually related to fuel charges.

Friday, July 11, 2025 President Martin reviewed and signed off on Bank Reconciliations for February, March, April and May 2025. An email was sent to Finance Chairman Ferguson requesting review of the Bank Reconciliations as well.

This morning, July 14, our RITA representative was onsite to review general instructions and reports with Mayor Abdella and myself. We are a mandatory filer for income tax. During the meeting, a report for Delinquent individuals, including non-filers, was provided to us. This report contains 2,928 individuals for the tax years 2019-2023. We will be sending letters to these individuals to file their taxes or to file the exemption forms within a specific time frame. Then they will be summoned to Mayors court in accordance with our ordinance and assessed interest and penalties. There is also a list of individuals that were on the failure to collect that totals \$241,002.38 that we will be looking to collect. Collection attempts will begin as soon as we receive RITA's collection letter template that we will customize, address, and mail. We hope to have these collection measures completed by August 1 or August 15.

The Public Depository bids have been received, and I have requested legislation to award the bid.

City Law Director Mr. Webster had no report.

City Treasurer Mrs. Cassady had no report.

Communication and Petitions: none

Council President Mr. Martin later mentioned the condition of the baseball field at Civitan Park. According to Mr. Martin the fields are atrocious. Mr. Locke and I were sitting down there the other day and there are trees growing in the fences and mowing was not done.

Mr. Locke stated that he was at the park recently and they have mowed and some of the trees have been removed from the fences.

Mr. Ferguson Finance/Audit Committee reported that his committee met on July 14, 2025 at 6:34pm for the purpose of reviewing the 2025 budget. The meeting ended at 7:15pm. Mr. Ferguson made a motion to add to tonight's agenda for first reading **A RESOLUTION**SUPPLEMENTING YEAR 2025 APPROPRIATIONS. A vote was taken with all members of council present voting aye.

# **UNFINISHED BUSINESS: -**

Mrs. Campbell brought before council for second reading **AN ORDINANCE TO AMEND BELPRE CITY CODE OF ORDINANCE SECTION 121.01(A).** A vote was taken with all members of council present voting aye. This will lie over until the next meeting of council.

Mr. Webster explained the Belpre City Code of Ordinance to the scouts present. We have to submit ordinances and resolutions to council for approval. They are sent to committee where they decide whether or not to request legislation. Once legislation is prepared it is placed on

the agenda and must be voted on three times where it is the final reading. Once it is passed it is adopted and becomes part of our Codified Ordinances for the City of Belpre. There are ways to pass in one night by suspending the rules of council. The legislation will have an emergency clause in the language of the legislation.

### **New Business:**

Mr. Ferguson brought before council for first reading **A RESOLUTION SUPPLEMENTING YEAR 2025 APPROPRIATIONS.** A vote was taken with all members of council present voting aye. This will lie over until the next meeting of council.

Mrs. Campbell brought before council for first reading AN ORDINANCE TO EXTEND THE ONE YEAR MORATORIUM ON THE ESTABLISHMENT OF INPATIENT OR OUTPATIENT ADDICTION FACILITIES, INCLUDING SOBER LIVING HOMES AND RECOVERY HOMES, WITHIN THE CITY OF BELPRE FOR AN ADDITIONAL PERIOD OF ONE (1) YEAR. Mr. Locke pointed out a typo to the legislation. He said that they need to amend 6 months to 1 year. Mr. Webster stated that the legislation would be amended before the next meeting. Mr. Ferguson asked when it would become effective? Mr. Webster stated that it is one year from when it becomes effective. A vote was taken with all members of council present voting aye. This will lie over until the next meeting of council.

Mrs. Campbell brought before council for first reading AN ORDINANCE TO AMEND BELPRE CODE OF ORDINANCES SECTION 1149.01 © LOT, YARD AND HEIGHT REQUIREMENTS FOR "C" AND "M" DISTRICTS. Mr. Locke asked what the EPA representative thought about this. According to Mayor Abdella this pertains to a manufacturing storm water coverage. Manufacturing has 35% coverage and Commercial has 85% coverage. Manufacturing property can be used for your coverage area that it is zoned. We have three manufacturing properties within the City of Belpre, one being Pioneer Casting, Boxers Bed and Biscuits and the site of the new Woman's and Children's Hospital at Marietta Memorial. The site is on manufacturing and if we take it and make it a C1 the hospital site will be in compliance when they start to build as Commercial Property. A vote was taken with all members of council present voting aye. This will lie over until the next meeting of council.

### **PERSON APPEARING BEFORE COUNCIL:**

Amanda Wires, President of the Belpre Homecoming Committee appeared before council inviting all members of council to the opening ceremonies on Thursday, July 31<sup>st</sup> at 6:30pm. Bobbie Walker stated that she really appreciates the communication between the Homecoming committee and the City of Belpre.
