CITY OF BELPRE ORDINANCE NO. #26 (2024-25)

AN ORDINANCE TO AMEND BELPRE CITY CODE OD ORDINANCE SECTION 121.01 (A)

WHEREAS, the Rules Committee for the Belpre City Council was assigned to review the starting time for the Belpre City Council meeting, and

WHEREAS, the Rules Committee held a committee meeting on June 9, 2025, at 7:00pm, and

WHEREAS, the Rules Committee found that persons in attendance desired to change the Council meeting from 7:30 p.m. to 6:30 p.m., and

WHEREAS, the Rules Committee voted unanimously that the new meeting time shall be adjusted.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:

SECTION I

Upon the reconsideration of the Rules Committee, the Belpre City Council finds that the agreed time change should be enacted.

SECTION II

Therefore, the Belpre City Council agrees to adjust the following amendment to Belpre Code of Ordinance Chapter 121.

“121.01 RULES OF COUNCIL

(A) Regular Meetings. The regular meetings of Council shall be held in Council Chambers on the second and fourth Mondays of each month, at 6:30 p.m.”

SECTION III

This Ordinance shall become effective at the earliest time allowed by law, but no later than the meeting scheduled for September 8, 2025.

121.01 RULES OF COUNCIL.

(a) Regular Meetings. The regular meetings of Council shall be held in Council Chambers on the second and fourth Mondays of each month, at 7:30 p.m. (Ord. 26(88-89). Passed 12-12-88.)

(b) Special Meetings.

- (1) The Mayor, three members of Council or the President of Council may call a special meeting upon at least twenty-four hours written notice to each member served personally upon or left at his usual residence or place of business, and upon at least twenty-four hours verbal or written notice to the news media that have requested notification, except in the event of an emergency requiring immediate official action. In the event of an emergency, the Mayor or members calling the meeting shall notify the news media who have requested notification immediately of the time, place and purpose of the meeting. Any person may, upon request and payment of a reasonable fee to be determined by the Safety-Service Director, obtain reasonable advance notifications of all meetings at which any specific type of public business is to be discussed.
