**A RESOLUTION AUTHORIZING THE BELPRE SAFETY SERVICE  
DIRECTOR TO ENTER INTO A CONTRACT WITH THE CITY OF  
BELPRE EMS, INC FOR THE PROVISION OF EMERGENCY  
MEDICAL SERVICES FOR THE CITY OF BELPRE**

**WHEREAS**, City is responsible to provide emergency medical services to the residents and visitors of their municipality; and

**WHEREAS**, EMS, Inc provides emergency medical services and is properly licensed by the Ohio Department of Public Safety to provide same; and

**WHEREAS**, EMS, Inc is an Ohio licensed emergency medical service and holds a license with the Ohio Board of Pharmacy; and

**WHEREAS**, City desires to utilize EMS, Inc as the primary provider of emergency medical services for its residents and visitors, in accordance with the terms and conditions herein stated; and

**WHEREAS**, EMS, Inc desires to provide emergency medical services for the residents and visitors of City; and

**WHEREAS**, the City of Belpre and the City of Belpre EMS, Inc. have previously had a three-year contract for the provision of emergency medical services; and

**WHEREAS**, the City of Belpre and the City of Belpre EMS, Inc. wish to enter into a new three-year contract for the provision of emergency medical services.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BELPRE, OHIO, THAT:**

## **SECTION I**

The Belpre City Administration and the City of Belpre EMS, Inc, have renegotiated a three (3) year contract between the parties. A copy of the proposed contract is attached as Exhibit A and incorporated herein by reference the new contract will be effective from July 1, 2026, to June 30, 2029.

## **SECTION II**

Upon the recommendation of the Belpre City Administration and after the review of the proposed contract by the Belpre City Council, the Belpre City Council believes that the contract is in the best interest of the City of Belpre to provide emergency medical services for its citizens. Therefore, the Belpre City Council hereby authorizes the Belpre City Safety Service Director to execute the contract attached hereto as Exhibit A.
